## **Class Details**

#### **Textbook and Materials**

LaunchPad Access for Macroeconomics 4th edition by Krugman and Wells (MacMillan Learning / Worth Publishers) http://www.macmillanhighered.com/launchpad/krugmanwellsmacro4/12969297

Purchasing access to LaunchPad is <u>required</u> for class. LaunchPad typically includes 6 months of access to an electronic book. The physical book costs extra and is completely optional. If you are an economics major, then I recommend you purchase the physical book so you can refer to it when you take future classes. Homework problems will be assigned and graded via LaunchPad. The due dates for the homework assignments can be found on the LaunchPad calendar. The UMaine bookstore should sell slips of cardboard with a LaunchPad access code printed on it.

Please bring paper (or some type of notebook), a writing instrument, and a calculator to every class. <u>Students will need a calculator</u> on the tests and final exam. Sharing calculators on tests will <u>not</u> be allowed. There is no need for a graphing calculator or anything programmable—a basic calculator will do. You will <u>not</u> be able to use your cell phone as a calculator on the tests or final exam.

#### **Course Details according to the UMaine Course Catalog**

Principles of macroeconomics and their application to modern economic issues and problems. Analysis of national income and employment; fluctuations in national income; monetary and fiscal policy; control of inflation, unemployment, and growth; and international aspects of macroeconomic performance.

Traditional A-F grading. No prerequisites or corequisites.

#### Grades

The class will be out of a total of 1000 points and will be divided up by online homework assignments through LaunchPad, three in-class tests, and one cumulative in-class final examination with the following weights.

Homework will be assigned on a chapter basis. In other words, each chapter will have its own homework assignment.

The table below gives the grade distributions by total points earned. These are minimum scores and <u>if need be</u>, I will introduce a "curve." The curve will consist of lowering the minimum score required for a particular grade. For instance, a typical curve may consist of making the minimum score for an "A" 930 instead of 935 points. You should <u>in no way depend on the curve</u> since the <u>curve is NOT guaranteed</u>, and if I do implement it, it may be very small. I will <u>not</u> curve individual assessments. All students should take all tests & exams. I will not drop any grades of <u>any assessments</u>. All questions regarding grades will be directed to this section in the syllabus.

If you already have an access code, select "I have a student access code," enter the access code, click submit, and follow any further instructions. If you still need to purchase an access code, select "I want to purchase access," enter your UMaine email address, click submit, and follow any further instructions.

#### **Online Study Tools**

LaunchPad contains a wealth of additional resources to help you study and to supplement class lecture. There are 9 interactive tutorials which are video lectures containing explanations of the course material, examples, and additional information. There are interactive tutorials for the following chapters: First Principals (Ch1), Supply and Demand (Ch3), Macroeconomics: The Big Picture (Ch6), GDP and the CPI: Tracking the Macroeconomy (Ch7), Long-Run Economic Growth (Ch9), Savings, Investment Spending, and the Financial System (Ch10), Income and Expenditure (Ch11), Aggregate Demand and Aggregate Supply (Ch12), and Fiscal Policy (Ch13). These range from 10 minutes to 40 minutes in length and I recommend watching them before doing the homework for that chapter.

LaunchPad also contains Flashcards and "LearningCurve" which provides sample questions in an interactive setting and tests your understanding of the material in the chapter. "LearningCurve" directs students to the relevant content in the e-book to assist them in getting the correct answer.

#### The Econ Lab

The Econ Lab, located in Winslow Hall room 205, provides students with a place to learn, gain assistance with introductory economics courses, receive advising support, and interact with other students. It is a great place to get tutoring or help with your homework in a principles class like ours. It is staffed by graduate teaching assistants who are eager to help you learn. It is open Monday through Thursday 10-noon and 2-4. The TA for our class, will be there during specific time, which I will post to online. While anyone staffing the Econ Lab can probably answer your questions, I strongly recommend you go to the Econ Lab when our TA is there. No appointment

#### What to Expect in Class

I primarily convey course content through writing on the board. I very strongly recommend that you take notes in class and write down anything I write on the board. With the exception of showing tables/figures, I do <u>not</u> use PowerPoint slides. You will find that the homework and test questions generally follow the class notes that I write on the board.

### **Class Policies**

#### Attendance

I will not regularly take attendance on a daily basis. In other words, I will not be passing around an attendance sign in sheet every day. However, attendance is expected and missing class is highly frowned upon. Throughout the semester, I may offer extra credit in-class quizzes or extra credit in-class activities in order to encouraging class attendance. <u>A student must be in attendance the day of the quiz or activity in order to receive the extra credit.</u> If you do miss a class, be sure to get the missed notes from a classmate.

If you miss a test, then your absence must be documentable. If it is a "of the moment" type absence, such as illness, please let me know at least by the morning before the class. If you are sick enough to miss a test, then you are sick enough to go to the University health services and get a note. If the absence was known in advance, such as jury duty or a family wedding, please let me know at least 3 days in advance. I reserve the right to see the documentation for the absence. With the exception of very extreme circumstances, such as being in a coma, final exam make-ups will not be given.

#### **Classroom conduct**

You are expected to act professionally. This expectation includes, but is not limited to: being quiet, silencing your cell phone, respecting other students, respecting the instructor, and asking questions by raising one's hand. If you are acting disorderly to the point where you are impeding other students' ability to learn, I reserve the right to ask you to leave the classroom.

Laptop computers are allowed in class only if there are used for legitimate class-related tasks, such as taking notes. If I find you using your laptop computer in class for tasks not related to class, then I will ask you to put your laptop away. Note that scrolling through social media on your laptop is extremely distracting to students siting behind you.

#### Late Work

Unless there is a "technical difficulty" with LaunchPad, no late homework will be accepted, so plan accordingly. Homework is submitted electronically via LaunchPad. Homework

submissions are typically due at 11:59 PM and the specific due dates can be seen on the LaunchPad calendar which will be updated regularly as we go through the class content.

If there is a "technical difficulty" with LaunchPad, take a screenshot of the error screen. Then send me an email explaining that you had a problem with LaunchPad and include the screenshot of the error screen. If I determine that the "technical difficulty" was legitimate, I will offer you a chance to resubmit the homework. If you experience some type of technical error with LaunchPad please notify me as soon as possible.

Doing the homework, but forgetting to press the submit button is not a valid excuse. In that case, you will not be allowed to retry the homework.

#### **Office Hours**

I will periodically use blackboard to communicate announcements and distribute course materials. I strongly recommend you set up your blackboard settings to automatically email you when a new announcement is posted. It is a good habit to periodically check blackboard and your UMaine email.

#### **Syllabus**

This syllabus should be considered a contract between me (the instructor) and you (the student). However, there may come a time when a change to the syllabus becomes necessary. In such an event, the change will be announced in class and posted to LaunchPad.
